World

"There are decades where only weeks happen, and there are weeks when decades happen."

The process of the politics of division and the move towards greater centralization of power in government will continue in 2023 in many countries. The year 2023 may, however, be transitional as a collection of failures manifest themselves in close temporal proximity.

A variety of social, political, economic, security, technical and health care related issues are reaching critical points. Each one by itself could cause major upsets, but several of them together may bring systemic change. The situation around freedom of speech remains fluid. While many governments are pushing "misinformation" narratives to silence free speech, others are pushing back. Central Bank Digital Currencies will be advocated by governments while the concept of 'climate lockdowns' will be pushed ahead by organizations such as the World Economic Forum.

The major international organizations designed to organize the international community and manage change have largely failed or been coopted into the globalist agenda. This includes NATO, the IMF, the World Bank, the EU, the UN, the OECD, GATT/WTO, ASEAN, and others. At the same time, it is reasonable to say that many leaders of these organizations (and sovereign states) are part of the globalization/destabilization problem, not a part of the solution.

In economic terms, a 40-year-long period of low-interest rates, stable inflation, 'cheap money', globalization, massive debts and financialization is coming to an end. The recession/depression that is developing may (optimistically) last five to seven years with the possibility of a sovereign debt crisis in several Western countries. Pessimistically, the recovery may take a decade.

From a security perspective, the war in Ukraine continues to escalate. The primary drivers of what is becoming a proxy war have become US Secretary of State Blinken and Under Secretary of State for Political Affairs Victoria Nuland. At the close of 2022, the European Union appears to have little policy input into the war and no control of the outcome. Ukrainian President Zelensky visited DC, but he has not visited London, Paris, or Berlin. An escalation of the war is likely in 2023, possibly by accident, but most likely by design. As with any war, it will develop its own dynamics and directions with no predictable outcomes.

The energy crisis in Europe (and to a lesser degree in North America) has been driven by misguided green policies and aggravated by the Ukraine War sanctions. This energy crisis, likely to continue into the winter of 2023/2024, may see the decline of Europe through deindustrialization and extreme energy costs for increasingly impoverished citizens. Social unrest, already beginning, is likely to spread. A further spike in food and housing costs may be the trigger.

Globally, several countries are facing civil unrest. This will be aggravated by the upcoming recession as well as the emerging food security problems. Among those facing possible violent social unrest are China, Peru, Iran, Argentina, Haiti, Pakistan, Russia, and Turkey. Additionally, increasing food and energy costs will increase social tensions and possibly create violence in much of Europe, especially France, Belgium, Germany, and the UK.

The "global pandemic" has been the greatest single driver of mistrust and hatred since World War Two. Trust in government, the media, the pharmacy industry, and the medical establishment have all been damaged. Institutions such as the World Health Organization and the World Economic Forum have used the opportunity to greatly expand their power at the expense of democracy and freedom of speech. The year 2023 will see the mRNA vaccines exposed for the problems they caused, including widespread deaths, infertility and increasing medical costs. The implications of this are not clear, but an outraged populace in many countries may turn on their governments and demand retribution, possibly in a violent manner.

Canada



1. Politics

The federal government of Canada will continue to push ahead with a variety of unpopular projects while increasing taxes and decreasing services. The gun grab will continue along with attacks on freedom of speech under the guise of keeping the internet "safe." The fossil fuel industry will remain the target of the federal government, along with farmers facing increased regulations and costs in inputs such as fuel and

fertilizer. A wild card in 2023 may be a federal election. The current minority government of Prime Minister Trudeau is relatively stable as its 'coalition' partner NDP party remains in lockstep with it. However, minority governments in Canada have a short lifespan. The key to the stability of the federal government is the economy. A significant recession/depression may cause the government to fall with an election to follow.

2. Economy

Canada enters 2023 in worse economic shape than most of its peers in the G7. Housing prices and debt levels are higher, while savings rates are lower. Taxes at all three levels of government will be forced to rise due to massive debts and increasing interest rates. Energy costs will continue to soar. Food shortages are not likely, but many Canadians will go hungry due to affordability issues. A 'hard landing recession' is likely to occur in 2023, led by a drop in housing. Canada's housing costs are among the most unaffordable in the entire Western world.

3. Health Care

Canada's single payer (socialized) health care system has gone from being a world leader to a complete laggard. Wait times are up, bed numbers are down, and availability is lagging. Drug shortages will become the norm in 2023. Given the current problems and massive new levels of immigration (500,000 legals plus illegals), the health care system will continue to crumble. Closed ERs and clinics are already being normalized while Canada's medically assistance in dying program (MAID) has gone from approximately 1,000 deaths in 2016 to 10,000 dead in 2021. In 2023, the government sponsored suicide program will be expanded to include teenagers with depression, the poor and the mentally infirm.

Your best choice for health care in Canada may be to eat well, exercise and remain healthy to avoid the health care system altogether.

4. Immigration

Despite a nation-wide housing crisis, the government of Canada will increase legal migration to Canada to 500,000 persons a year starting on 2023. This is up from an earlier norm in 2015 of 150,000 persons a year. The high levels appear to have more to do with social engineering than the economy.

5. Social Cohesion

The current government of Prime Minister Trudeau has used the politics of division and hatred to effectively manage his control of parliament and gain re-election. This policy shows no signs of abating. Given the widespread discontent stirred up over the last seven years, a sharp downturn in the economy and hunger caused by soaring food prices may cause (violent) social unrest.

Germany



1. Coronavirus.

The government with the media has managed to split society and, in my opinion, created a complete neural disaster in the population's heads. Instead of contradicting and rejecting the pandemic dictate because of their maturity, a large part of the German population appreciated the measures and supported the state terror (Stockholm Syndrome) with denunciation and defamation.

2. Vaccination compulsory in the Bundeswehr

In anticipatory obedience, the Ministry of Defense decided to enforce vaccination with the non-fully approved therapeutic agent against a non-fully isolated virus based on the obligation to tolerate. The legality of this order to the soldiers is still disputed and is reflected in the resistance of some soldiers to comply. They accept politically motivated reprisals from their highest employer, the minister of defense. The only possibility of resistance thus inevitably leads to a court case. In the meantime, this vaccination order has been called into question by some courts due to the data situation. This is not least due to the meager evidence of the Bundeswehr. Unfortunately, no precedent has yet been set to protect soldiers from this gene experiment. In the meantime, the troops have also refrained from the fourth vaccination. There is hope!

3. State action countering protests against corona measures

The fact that the state used maximum police force against demonstrators can be proven by numerous images and film material. This crackdown eventually became the subject of investigations by the UN Human Rights Commission.

The behavior of the government in solidarity with the media led to brutalization of verbal exchanges within society. Both psychological and partially psychological violence related to the pandemic increased. Society was brutalizing its own citizens.

4. Behavior of the government and Bundeswehr in Ukraine war/arms delivery

Similar behavior as in the Corona crisis can currently be observed with the Ukraine-Russia war: the media support the government in their narrative. The critical way of looking at the conflict is more and more pushed into the background. Increasingly, the only thing that counts is that the masses believe that Putin alone is to blame for the war. Any critical questioning is increasingly disappearing and is being suppressed not only by the government and the media, but by the uncritical masses. The government's actions in relation to arms shipments are presented as legitimate and any questioning is classified as "immoral." The troops are hollowed out by the politicians and act in typical military obedience. However, the troops do not belong to the politicians, but to the people! Especially now it is important to be able to form your own opinion. This also means that you don't just allow yourself to be showered with information, but actively dig for information. The critical spirit goes independently in search of the truth. And finding the truth is often easier than taking everything uncritically from the mainstream media.

1. Corona gesellschaftlich

Die Regierung mit den Medien hat es geschafft die Gesellschaft zu spalten und meiner Einschätzung nach eine komplettes neuronales Desaster in der Bevölkerung geschaffen. Statt dem Pandemie-Diktat aufgrund der Mündigkeit zu widersprechen und es abzulehnen, hatte ein Großteil der deutschen Bevölkerung Verständnis für die Maßnahmen und unterstützt mit Denunziation und Diffamierung den Staatsterror (Stockholm-Syndrom).

2. Impfpflicht in der Bundeswehr

Im vorseilenden Gehorsam hat sich das BMVg für die Durchsetzung der Impfung entschieden mit dem nicht vollständig zugelassenen Therapeutikum gegen einen nicht vollständig isolierten Virus auf der Grundlage der Duldungspflicht. Die Rechtmäßigkeit dieses Befehls an die Soldaten ist nach wie vor umstritten und zeigt sich im Widerstand einiger Soldaten, diesem Befehl nicht zu folgen. Sie nehmen politisch motivierte Repressalien durch den Dienstherren in Kauf. Die einzige Möglichkeit der Gegenwehr mündet somit zwangsläufig in einem Gerichtsprozess. Inzwischen wurde von einigen Gerichten dieser Impfbefehl aufgrund der Datenlage in Zweifel gezogen. Das liegt nicht zuletzt an der dünnen Beweislage der Bundeswehr. Leider konnte noch kein Präzedenzfall geschaffen werden, um die Soldaten vor diesem Genexperiment zu schützen. Inzwischen hat man auch in der Truppe Abstand von der vierten Impfung genommen. Es kann gehofft werden!

3. Staatliches Vorgehen bei Demos gegen Corona-Maßnahmen

Dass der Staat mit maximaler Polizeigewalt gegen Demonstranten vorgegangen war, lässt sich zur zahlreichen Bild- und Filmmaterial belegen. Dieses harte Vorgehen wurde schließlich sogar Gegenstand von Ermittlungen der Kommission für Menschenrechte der UN.

Das Verhalten der Regierung im Schulterschluss mit den Medien führte zu einer Verrohung des verbalen Austausches innerhalb der Gesellschaft. Sowohl psychische als auch teilweise psychische Gewalt im Zusammenhang der Pandemie nahm zu. Die Gesellschaft verrohete.

4. Verhalten der Regierung und BW im Ukraine-Krieg/Waffenlieferung

Ähnliches Verhalten wie in der Corona-Krise kann man aktuell mit dem Ukraine-Russland-Krieg feststellen: Medien unterstützen die Regierungen in ihrem Narrativ. Die kritische Betrachtungsweise des Konfliktes gerät mehr und mehr in den Hintergrund. Zunehmend zählt nur noch, dass die Masse daran glaubt, dass Putin allein Schuld an dem Krieg hat. Jegliches kritisches Hinterfragen verschwindet zunehmend und wird nicht nur von Regierung und Medien, sondern von der unkritischen Masse unterdrückt. Das Handeln der Regierung im Bezug auf Waffenlieferung wird als legitim vorgegeben und jegliches Hinterfragen als „unmoralisch“ klassifiziert.

Gerade dann jetzt ist es wichtig, seine eigene Meinung bilden zu können. Dazu gehört auch, dass man sich nicht nur von Informationen berieseln lässt, sondern aktiv nach Informationen gräbt. Der kritische Geist macht sich eigenständig auf die Suche nach der Wahrheit. Und die Wahrheit zu finden ist oft einfacher, als dass man alles unkritisch von den Mainstreammedien übernimmt.

[Dutch / Flemish Experts banned vs MSM experts:](#)

Start of 2022 there is a lot of civil unrest in the Netherlands. Two years of polarization, the revival of facemask mandates despite all the controversy, limitation on the number of visitors for the holidays, out casting of non-vaccinated from hospitality and travel restrictions, which amounted to increased pressure to take the vaccine.

Despite a history of malpractice by the Dutch government, for instance in the Child Surcharge Affair (kindertoelagenaffaire) in which they've been found guilty of malpractice with disastrous results for the involved families being torn apart, bankruptcies, divorces, and suicides as a result. Even though, Rutte and his cohorts are still in power and continuing to roll out the WEF Agenda 2030 in which the Netherlands is planned to play a decisive role as the gateway country and central point in the Tristate city which is the root cause of destroying of national food production and farming, and many other initiatives to destroy democracy and free will.

Still, the supposed experts like Marion Koopmans (NL) and Ab Osterhaus (NL) reign the social media in Holland, and Marc v Ranst (BE) in Belgium is making all kinds of absurd and fascistic claims. Much supported by public figures from Football tv shows and many others. Some public figures speak out like Remy Bonjasky and Wesley Snijder, but they are few and get little attention in the media. Meanwhile, there are some renowned experts in immunology and vaccines like (NL) Theo Schetters (NL) and Geert vanden Bossche (BE) that get no screentime, nor does Matthias Desmet (BE) while his research in mass psychosis is invaluable knowledge today.

On the 2nd of January, there's a big protest planned by 'Together For Netherlands' (samen voor nederland) a collaboration of all major protest initiatives who came together in 2022-09-05 in an attempt to join efforts and increase the number of protestors to try and show the scope of non-compliant Dutch people. The protest was forbidden for the dubious reason of a planned strike by the riot police that day (they still turned up and in vast numbers). Despite the prohibition, many protestors still came to Museum Square in Amsterdam, as did our group then still known as IHGVV (in het gelid voor vrijheid). It was a very hostile situation, many body searches for weapons before the police instigated their plan to sweep the square and drive the peaceful protestors into a police blockade, most likely to trigger an escalation so they could impose even stricter regulation. The plan misfired, partially by the efforts of the Dutch veterans a corridor was created despite being violently opposed by the riot police and Arrest Team (arrestatie eenheid), and in a role reversal this time the police were protected by the Line created by us. As a token of their appreciation, after 2 failed attempts the third time they came with 4 arrest teams to arrest our Liaison and a total number of three arrests. In the weeks that followed, driven by the necessity for the safety of our group members a few of us decided to answer the call of the MSM to resist the framing of our group

and a possible outcome of being labeled a vigilante organization reinstating laws last seen in NL in WWII. By straining effort, we managed to withstand, but not without internal damage between our brothers which later turned out to rupture our group. After this, the Dutch government received heavy criticism amongst others by Euro parliamentary Cristian Terhes (Romania) who witnessed the event and spoke out. UN torture reporter Nils Melzer mingled in the debate and went to investigate the situation. This debacle forced the Dutch government to change their approach coinciding with IHG efforts to improve communications with the onsite Commander of Police, successfully, and in the following weekly protests we consolidated many relations with different Police Corps Commanders and after months this resulted in a cessation of violence by police at peaceful protests.

In stark contrast was a protest in Brussels on January 23rd in which we attempted the same in our neighboring country, but a first seemingly compliant commander of police turned out to be looking for escalation by negligence and a huge confrontation at Jubelpark turned into violence from both police and rioters who had little to do with the actual purpose of the protest but conveniently gathered in Brussels which turned the city into a situation similar to what you might see in countries at war or the prelude to it.

War is announced in Ukraine and the whole focus on Covid is abruptly halted. The mass population follows eagerly, oblivious to the pre-history of Ukraine and the nazistic practices they have put their population under. Even the MH17 crash of 2014-07-17 seems forgotten and the politicians and media jump at the opportunity to promote war and anti-Russian propaganda. Quote of Rutte during a debate: “die oorlog daar is de onze” (that war there is ours). He continues to say that if the war is not won, the Dutch people will be in danger, and they decide to supply heavy weaponry from an already hollowed-out Dutch Army reducing our military preparedness to nil. So far, no Dutch envoy of military personnel has been deployed in Ukraine but exercises on the edge of the territory have been multiple.

As part of the Tristate Agenda 2030, the Dutch cabinet has started severe restrictions on farming businesses with CO2 emission limitations and a Nitrogen emission goal of zero. In the past farmers have been forced to grow their business to keep up with competition and now that only the large remain, they're imposed with neigh impossible targets for the reduction of CO2 but mostly Nitrogen emission. The top 500-600 farms on the emission scale must reduce to zero which of course is not possible. We even have a minister of Nitrogen, which is hilarious more so because apparently Nitrogen problems stop at the border because neither Germany nor Belgium impose any such restriction. At the same time other industries like garbage disposal vastly transgress the limitations enforced on farming but these are not included in the green deal plan adding to disbelief and despair among Dutch Farmers.

Notoriously kept to themselves since the beginning of the Covid agenda some figures have tried to unify the farmers to little effect. Now that they are being targeted, they gather and begin a series of protests by blocking roads and municipality buildings. Attempts to unify these protests with the covid protests fail, mostly because farmers aren't looking at the world problems but just their own, and simultaneously since

they're still hooked on MSM the polarizing efforts by the media make farmers not want to mingle with 'wappies' (nickname for critical thinkers, negatively expressed: crazies)

The protest only really takes form in the north, some in the east but none in the south, which is dense with farmers. No national efforts are successful and after perhaps 2 months the strength and impact of resistance by the farmers dwindles and diminishes. Uncertainty of livelihood for farmers drives many of them to sell out, also because for example, Schiphol airport is generously buying up bordering farmland and for housing projects, farmers are offered up to 20% over market price value for their properties. In the fine print of the contracts, it says they must agree to never work in their vocation again. As one of the largest exporters of food produced by this we do not just lose our own food security, we also vastly limit importing countries' food supplies by this act of government. Having seen what shortages of food can do to a population, doubled by the softness of western Europeans due to more than half a century of welfare can turn a 1st world country into chaos within weeks but also this goes right by the public who is not interested in facts and are all too happy they can visit the restaurant of their choice again. But for how long.

Energy crisis:

Because of the Ukraine conflict, or so they say, the Netherlands enters an energy crisis. Fuel prices rise at the start of the year and maintain absurd amounts of over €2,30 for gasoline and even more ludicrous higher diesel prices than gasoline which we have never seen. Of course, this has the most impact on self-employed people who have always been coaxed to use diesel as a cheaper alternative. In the second part of 2022, the discussion about the coming winter and shortages arise. Energy prices rise to soaring heights, gas is being sold to Dutch citizens for higher prices than any other country, including the countries we export our gas to! People are lured to get off gas in their homes, while Germany subsidizes it. By getting off gas, electricity use rises and as a result, the media speaks of exertion of the electricity grid by private solar panel owners, and they start shifting down privately owned solar systems. As for now, there is a "salderingsregeling" which deduces production from consumption, but this will be built in coming years so all who invested in solar panels are confronted with increasingly detrimental factors. This act of control of the energy supply raises fear of livelihood across the Dutch population and many families who were doing well before face a cold winter, and small businesses must decide to better reduce production or close because of high energy prices making it too difficult to keep their business going.

Unrest within resistance groups:

The reduction in the number of protests and the nonviolent behavior of the police caused unrest in our group. Simultaneously in other groups, the same energy flowed, as we learned later. It started small, seemingly insignificant at first, but it grew and what seemed an unrelated issue became many different unfounded issues in which we perceived similar behavior of one-sided information as the mass population which they so-called sheep but now imitated as if never happened, and with distrust growing and even experiencing a coup within our group while the ones giving direction being accused of the coup itself we experienced three months of turmoil, disbelief and dismay it all resulting in the decimation of our group to 20% of its former size. In hindsight, it can be seen as a necessary event and witnessing it happening in groups all through the government critical community, we can describe it no other as a shared energy in this zeitgeist.

On November 6th at the Samen Voor Nederland rally David Icke was invited to speak on stage. CBDC:

Rabobank, which is one of the main, and known for being 'the farmers' bank' has started investigations on any withdrawal of over 100 euros. Citizens can receive inquiring emails and letters as to the purpose of these withdrawals. In supermarkets, cashless machines are replacing tellers in rapid succession.

Banning Political Parties:

Currently, there are several indications that the government intends to introduce the possibility to ban a political party for critical expression. Targeted here mainly would be FVD (Thierry Baudet) which has been critical all through these last years as the main opposition party. They grew in size, which makes them more of a focus point of the ruling parties (VVD (Mark Rutte), D'66(Sigrid Kaag), CDA(Hugo de Jonge), Christenunie (Gert-Jan Segers) and they face heavy ridicule and invalidation by their peers.

Noncompliance and counter polarization by regional initiatives:

Besides all the attempts of division, polarization, and ostracizing there are also increasingly many and growing initiatives among the Dutch population that paint a hopeful and positive picture of the future.

Acts of selfless compassion create many renewed bonds and connections between the people of the so-called 'parallel society'. In the dark days of December people show their compassion by giving out food, and clothing and reaching out to their fellows and neighbors who are already suffering from inflation, unemployment, and many other constricting and confining changes in their lives under the rule of the current government. Resistance is not only through not compliance but also by showing an alternative to the current status quo through acts of humanity, charity, and neighborly love for one another. Despite the picture painted by MSM, there are many here who don't agree with the current situation, and the answer lies in interconnecting, forming strong bonds, facilitating basic necessities regionally, canceling dependency on central government, and putting the power back at the people, where it belongs.

New Zealand



What a crazy year we have observed both here in little old New Zealand and globally.

Our vaccine acquisition and rollout began in earnest around April 2021, which was later than many northern hemisphere countries mostly due to the government failing to secure a contract early enough, but also ostensibly because we had an opportunity to wait and see what happened during that second Covid winter in the north. Confusingly, frontline workers were selected as the group for immediate vaccine mandates (before the elderly and vulnerable) - this included the New Zealand Defence Force (NZDF) as we were heavily involved in providing the resource for our border entry Managed Isolation and Quarantine (MIQ) facilities. We managed these facilities without breakthrough incident and without vaccines for over a year. I believe the decision to vaccinate NZDF personnel first was because the government knew they could ensure high uptake in Defence personnel, thus demonstrating 'evidence' that the vaccines were indeed 'safe and effective'.

Almost immediately a small group of us banded together and established a legal challenge of the mandate by Judicial Review at the High Court. This was a long and drawn-out process involving many different challenges. Eventually, though, our group which now includes affected NZ Police and Fire Service personnel under the parent brand 'United We Stand' were successful on Mar 22 when the Courts ruled that the government mandate for NZDF and Police staff was unlawful (being an unjustified limitation on human rights), causing that legislation to be rescinded. The Fire Service quickly rescinded its policy as well.

Cynically though, the NZDF then generated its own internal mandate and unfortunately, our Judicial Review for that mandate was unsuccessful later in the year. We have appealed that finding and that hearing is scheduled for April 23.

Coincidentally, at the same time as our case was being heard in Feb an almost spontaneous protest occurred on parliament grounds in Wellington, which followed on from a Trucker Convoy movement that traveled from both ends of the country and met in the nation's Capital. Initially, this started out as a copy of the Canadian Freedom Convoy and gained thousands of supporters as they traveled the country. Although the leaders of the convoy hadn't planned it, once they got to Wellington someone made the decision that they should camp out, and the movement grew from there. At its peak, the protest attracted 10,000 people a day to the Freedom Camp. The protestors demanded an audience with a sitting MP to discuss Covid policies and specifically vaccine mandates which at that time were widespread in some major sectors including Defence, teaching, Police, Fire and Emergency Services, hospitality, and the health sector.

The 'occupation' of Parliament lasted three weeks and was quite the feat of logistics, liaison, and advertising. It ended abruptly on 02 March when hundreds of police in riot gear and firing rubber bullets moved through the camp destroying tents and arresting 65 people. The 'occupation' gained international media attention and huge amounts of support from the public of NZ, with some reports stating up to 30% of kiwis supported the protestors and many more were against the vaccine mandates. There is no doubt that this widespread support was instrumental in the rescinding of the various mandates shortly thereafter.

In general, our vaccine booster rollout has lost much momentum this year due to loss of public support for this and related government policies that were so vehemently demanded the year before. Almost all public restrictions have been removed, the only two that remain are the NZDF internal mandate and a mask requirement in a healthcare setting, although the vaccine requirement for the healthcare sector has been pushed down to the District Health Board level (it was previously legislated by the government as part of the COVID-19 Public Health Response Orders). The government has not re-implemented any previous restrictions despite facing the latest 'wave' in Nov-Dec of this year and receiving much criticism from the more zealous and fearful commentators in NZ. However, even during this current 'wave' which

has seen a high rate of daily cases, associated deaths have remained consistently very low, due mostly to widespread exposure to Omicron roughly around March this year in the previous wave.

The Prime Minister Jacinda Ardern has been unabashed in her public support of the WEF, meeting with Klaus Schwab at the East Asia Summit in Nov, having previously visited Blackrock offices in New York in June. Political support for Centralised Banking Digital Currency continues to grow, boosted by the widespread deployment of a vaccine pass in 2021, which was eventually dropped early in 2022.

The in-power Labour government continues to lose favour among the voters here in NZ due to a plethora of controversies including mismanagement, a destroyed economy, and a litany of bare-faced lies in many examples. This involves Covid policy, financial policy related to the pandemic, international relations, national water management, and health infrastructure changes.

One of the oppositions (National Party) stated election promises was the initiation of a Royal Commission of Inquiry into the pandemic response once they get into power, which the current government has euhred by initiating their own enquiry. This is a smart move by a PM on her way out as they have been able to not only select the areas of investigation to be included in the Inquiry (notably missing vaccine safety or efficacy) but have selected their own Chairperson- Tony Blakely, a Kiwi epidemiologist now based in Melbourne who was an advisor to that government which enacted the harshest lockdowns and restrictions in the Western world. The results of the Inquiry then are all but a foregone conclusion, the results of which we do not expect until sometime in 2024, long after the current government is removed from power anyway.

In the wake of the protests many new parties and potential representatives have been created or put themselves forward for roles in local and National elections. This has been caused largely by the current government's ineptitude coupled with the opposition's unwillingness to act in a true oppositional way. Labour seems to be moving left and the opposition is moving left to keep up, leaving a vacuum on the right that these fledgling parties are clamouring to fill. The next election will likely see the National Party take power but not with a clear majority, but this will likely *not* lead to a major swing in the type of policies that will be enacted and will almost certainly *not* result in the rescinding of the major policies that have been rushed through this year by Labour- who sense their impending demise- despite National's promises to do so.

Finally, you may have heard of the 'Baby Will' case where a family was demanding unvaccinated blood for their baby who required a blood transfusion as part of urgent heart surgery. This went to the High Court also, with the Courts ordering the baby be removed from the parents and put into State care so the operation could be carried out. We have heard anecdotal reports that somehow the baby was provided unvaccinated blood, if real this was likely done to ensure that there were no repeat protests to those observed earlier in the year after an outcry from 'anti-vaxxers' following the ruling on the case.

United Kingdom



1. Boris Johnson finally lost support of his party and the back bench committee of influential MPs and was forced to resign in July. There were numerous reasons including: breaking of his own Covid19 rules as detailed in the Gray Report, his handling of the Chris Pincher MP sexual assault allegations, and the breaking of lobbying rules by Owen Paterson MP. This triggered a leadership election and hence a new Prime Minister for the UK. Liz Truss, surprisingly won the leadership election and became PM. She was not a popular choice amongst the conservative party or the British people. In her previous role as “Secretary of State for Foreign, Commonwealth and Development Affairs” she openly encouraged UK citizens to go and fight as mercenaries in Ukraine.

One of her first actions as PM, and somewhat surprising, was the announcement that she would tackle the looming energy crisis in the UK by striving to make the UK more self-sufficient for its energy and signalled the green light for fracking (Shale Gas, hitherto banned in the UK) and development of new oil and gas exploration. She also introduced an energy price cap for consumers. This was out of synch with the globalist agenda that the UK had been pursuing.

She never looked comfortable in the role and a controversial mini budget signalled she was losing control. One thing she did that deserves a special mention was to secretly sign the UK armed forces in to part of the EU PESCO initiative, namely the Military Mobilisation element. This was highly controversial, especially among the pro BREXIT MPs. This paves the way for the UK to be dragged into any military action instigated by the EU.

Her tenure was short-lived, and she resigned after 44 days in office. Although a WEF “Young Global Leader” she was probably not willing or able to carry out the more aggressive WEF instructions. The second leadership election resulted in Rishi Sunak becoming PM. I think this all could have been theatre and a smokescreen to get SUNAK, the globalists preferred candidate to power.

The globalist agenda has been greatly accelerated since his appointment. The UK, as part of the G20 meeting in Bali, agreed to adopt “vaccine passports with the purported goal to promote global travel and tourism”. The movement towards Digital ID and CBDC has been announced, the latter despite the House of Lords report finding that there was no reason for adoption. A quote from their report said, “CBDC was a solution looking for a problem”!

2. Energy Crisis

A major issue in 2022 was the government’s decision to reduce the cap on energy bills. This is a difficult and complex subject. The typical energy bill doubled in 2022 and was about to double on at least two more, occasions. The Liz Truss announced price cap and energy exploration has been reversed by Rishi Sunak and his new chancellor (Jeremy Hunt). It is no longer clear what the future increases will be, except they will be substantial! Of course, the war in Ukraine is blamed for the price increases and expected power outages planned for early 2023! This has huge sway in a country in fear of not being able to heat their homes and businesses. There has been no support announced for businesses. Many small businesses, like pubs and restaurants are facing bills they cannot possibly meet, making the businesses unviable (certainly during the winter months!)

3. Climate Lockdowns

With Agenda 2030 plans firmly embedded in every facet of our country (just like many in the western world), 2022 saw the first announcement of the so-called 15-minute cities. Oxford and Canterbury have been announced as the first two cities to trial these plans. The city centre will be divided into zones that are about 15 minutes wide (walk, cycle). Transport by car will only be permitted across these zones one hundred days a year. The fine details have yet to be released. You may be able to access these zones but only by following a specified route. In Oxford this would be via the city's ring road! This is to reduce the Carbon emissions of the city. Many of us know that Carbon (Co2) is NOT really a pollutant but has been labelled as one to facilitate the Climate Emergency madness! These plans have received some derision even in the more mainstream press, like TalkTV and GBNews. The MSM has essentially ignored these announcements,

4. Covid-19, Lockdowns and Vaccine Mandates

The lockdowns in the UK ended in late 2021 and the relaxation of the restrictions continued in to 2022. The biggest breakthrough was the NHS dropping its vaccine mandate. Thousands of NHS doctors and nurses were facing losing their jobs before the government dropped this mandate. Unfortunately, it came too late for many in the nursing home profession, who had already been made redundant or forced to have the job. This was the same in the Armed Forces and the Police service, many of which had been forced to make that difficult choice. To my knowledge these professions are still subject to the vaccine mandate, though I suspect in practice there has been some relaxation of the pressure. Masks have largely disappeared. They are no longer required in shops, public transport or even Doctors' surgeries. They were

also removed as a requirement for Hospitals, but many NHS trusts decided to retained mask use, despite the change in government guidelines. In practice, their use is not strictly enforced.

Vaccine damage is getting a small amount of coverage in the MSM and even a very small number of MP's have become aware of this major issue. Several debates and even presentations to parliament have taken place. One worth mentioning was by Dr Aseem Malhotra (a man with an international reputation), who addressed the "All Party Parliamentary Group (APPG) on Vaccine Damage" on October 20th. Dr Malhotra published peer-reviewed research that concluded that there should be a complete cessation of the administration of the mRNA vaccines for everyone because of clear and robust data of significant harms and little ongoing benefit. He described the roll-out of the BioNTech-Pfizer vaccine as:

"perhaps the greatest miscarriage of medical science, attack on democracy, damage to population health, and erosion of trust in medicine that we will witness in our lifetime."

Only four MPs attended this presentation (and they were all members of APPG). Other debates on vaccine safety have also had very low attendance by MPs and resulted only in derisory comments from MPs who do not want to hear the facts about these experimental gene therapies. One of these MPs was Andrew Bridgen who recently spoke on vaccine safety and claimed that vaccine damage was being deliberately hidden. He stated that the claims made by Dr Malhotra have not been challenged or rebutted. He is getting a lot of heat for raising these issues. There are many medical professionals now starting to speak out about vaccine safety.

5. War in Ukraine

This likely came as a shock to the UK, as many did not think Putin would fall into this trap. The British public have been subjected to, just as with Covid and climate change, the full onslaught of applied behavioural science via the BIT (Behavioural Insights Team), now part of the cabinet Office, and essentially part of the inner core of the government.

The UK is under attack from the most blatant propaganda. The British public knows nothing about how Zelensky came to power, the attacks on ethnic Russians in the Donbass region since 2014, the planned invasion of Crimea by Ukraine, and the blocking of any peace negotiations by NATO/Western leadership. Many who follow the truth on alternative media platforms are concerned that a NATO false flag is very likely. To cause full-scale war between NATO and Russia. It was recently admitted that the Royal Marines have been deployed to Ukraine on secret missions. This included the operation to assist in the exodus of UK personnel from Kyiv in the early part of the Russian "Special Military Operation," but may have been used for other covert operations. This admission signals that the UK and therefore NATO is essentially already directly involved in direct conflict with Russia.

6. Immigration

The UK has been subjected to unprecedented levels of illegal immigration in recent years. The vast majority are coming from France and are attempting to cross the channel in small boats. The latest plans are to relocate many of these men to the countryside to assist with farming and boost the local economy. The government agencies responsible for immigration have been failing for years. *Migration Watch*, an independent think tank, published the following official figures: The UK population stood at sixty-seven million in 2020/21 (and rose by eight million or so over the previous twenty years, with about seven million of this directly or indirectly linked to immigration). Fifty percent of this is likely illegal and this does not include those not known to the authorities.

7. Queen Elizabeth II Dies

Seven months later, Soriot – born and raised in France, a citizen of Australia and a Doctor of Veterinary Medicine – was awarded a knighthood in the Queen's Birthday Honours 2022 for services to UK life sciences and the response to Covid.

It's likely we will see more of this, despite the protocol that the monarch should NOT engage in political activities. King Charles said he would stop his political activism now he is King, but he will likely not honour his pledge!

United States
